Set Date – Public Hearing – Yield Sign corner of Sunset Dr. & Manor Dr.

Attorney Frateschi and Highway Superintendent Cushing reviewed a request for a yield sign at the corner of Sunset Dr. and Manor Dr.

Conversation ensued regarding the location of current yield signs at the intersection. Highway Superintendent Cushing stated that he will confirm the location of any existing yield signs. The Town Board directed Attorney Frateschi to amend the resolution calling for a public hearing to include the existing yield signs that were not stated in the town code.

Councilor Bollinger made a motion, seconded by Councilor Green, to set a date for a public hearing on July 24, 2019 at 6:40 pm in the matter of a Yield Sign at the Southwest corner of Sunset Drive at Pleasant Drive, the Northeast corner of Sunset Drive at Pleasant Drive and a sign at the most western part of Manor Drive at the Southeast corner of Manor Drive at the intersection of Sunset Drive as outlined in the amended resolution prepared by the Attorney for the Town.

Discussion:

Councilor Bollinger asked if the town should notify the nearby properties within 500 ft of the proposed additional yield sign. Conversation ensued regarding the difference between a stop sign and a yield sign.

Attorney Frateschi stated that there is no requirement in the Town Code to notify residents of the installation of a yield sign.

Highway Superintendent Cushing stated that the installation of the yield sign does not create a new control device at the intersection. Highway Superintendent Cushing stated that the traffic rule to yield at the intersection already exists and the installation of the yield sign would be informative and not a change to the traffic law.

Councilor Bollinger stated that she is fine not issuing the notification because the yield sign is not changing the behavior in the intersection.

The Town Board discussed the existing yield signs and requested that those yield signs be added to the notice and resolution so that the Town Code and the existing yield signs are congruent.

Harley Davidson Lease – Police Department

Chief Crowell stated that the Manlius Police Department Harley Davidson Motorcycle lease is expiring, and they are requesting it be renewed. The lease for the motorcycle is paid for with the STOP DWI funds that the Town receives.

Councilor Green made a motion, seconded by Councilor Giordano, to authorize Chief Crowell to sign the motorcycle lease with Harley Davidson.

Court Security Contract – 3 Officers

Attorney Frateschi presented 3 court security officer contracts between the Town of Manlius and the New York State Unified Court Officers.

Town Manager Oot confirmed that these contracts are for officers that are replacing existing officers. Town Manager Oot stated that the presented contracts are exactly the same as the contracts that were approved for the other court security officers in the beginning of the year.

Councilor Marzola asked if there has been any lapse in the security service provided. Town Manager Oot stated that there has not been any lapse in security coverage for the court.

Councilor Green made a motion, seconded by Councilor Giordano, to authorize the Town Supervisor to sign the contract for court security officer Stephanie Gburek.
