**BOND RESOLUTION OF THE TOWN BOARD OF THE TOWN OF MANLIUS,
ONONDAGA COUNTY, NEW YORK (THE “TOWN”), AUTHORIZING THE
ISSUANCE OF UP TO \$13,693,000 IN SERIAL BONDS OF THE TOWN TO
FINANCE CERTAIN IMPROVEMENTS TO THE TOWN’S SKYRIDGE WATER
DISTRICT**

Councilor _____ moved and Councilor
_____ seconded the following Resolution:

WHEREAS, pursuant to proceedings undertaken by the Town Board (the “Town Board”) of the Town of Manlius, Onondaga County, New York (the “Town”) under Section 202-b of the Town Law, including in particular a resolution adopted on July 29, 2023 immediately prior to the consideration of this resolution (the “Approval Resolution”), the Town Board determined it was in the public interest to undertake certain improvements to and for the benefit of the Town’s Skyridge Water District, including the construction of the following: (i) 31,000 linear feet (6-miles) of 8-inch ductile iron pipe water transmission and distribution main; (ii) ten (10) hydrants spaced along the transmission main and within the Water District; (iii) thirty-one (31) mainline valves spaced no more than 1,000 feet apart; (iv) twenty-nine (29) ¾-inch copper water service laterals extended to the highway right-of-way boundary (Water District only); (v) one (1) water service feed to the Clear Path at Skyridge LLC parcel fronting Salt Springs Road, comprised of an 8-inch ductile iron pipe and isolation gate valve; (vi) 178,000 gallon glass fused-to steel water storage tank and access road; (vii) one (1) package booster pump station with emergency on-site generator; (viii) three (3) mainline pressure reducing valve (PRV) pits for maintaining water pressures generally below 80 psi; (ix) connections to the OWCA water system near the intersection of Salt Springs Road and North Eagle Village Road in the Town of Manlius, Onondaga County, and to the 8-inch distribution main serving the Town of Sullivan’s Sleepy Hollow Water District in Madison County; and, (x) decommissioning, demolition and/or removal of the existing wells, tank and distribution mains serving the Water District (collectively, the “Project”), at an estimated maximum cost of \$13,693,000, including the

issuance of serial bonds and/or bond anticipation notes issued in anticipation of such serial bonds in an amount not to exceed \$13,693,000; and

WHEREAS, by resolution adopted on July 29, 2023, immediately prior to the adoption of this resolution, the Town Board (i) determined that the actions to be undertaken in connection with the Project (collectively, the “Action”) constitute a “Type I” action pursuant to the provisions of the New York State Environmental Quality Review Act and the regulations promulgated thereunder (6 NYCRR Part 617) (collectively, “SEQRA”), (ii) assumed lead agency status for purposes of conducting a coordinated review of the Action in accordance with SEQRA, (iii) authorized the Supervisor to take all actions, serve all notices, and complete all documents in order to give full force and effect to the amended SEQRA process; and (vi) based on its coordinated review of the Project, determined that the Action to be taken in connection with the proposed improvements would not result in, or cause any significant adverse environmental impacts, adopted a “Negative Declaration” pursuant to SEQRA with respect thereto, and directed that a notice of Negative Declaration be filed and published, to the extent required under SEQRA; and

WHEREAS, the Town has or will have applied for and expects to receive certain federal and/or New York State grants to offset a portion of the cost of the Project for which the Town may be required to finance such amounts in anticipation of the receipt thereof; and

WHEREAS, the Town Board now wishes to appropriate funds and to authorize the issuance of the Town’s serial bonds and bond anticipation notes in anticipation thereof in order to finance the Project or in anticipation of the receipt of such federal and New York State grants used to finance the Project; and

WHEREAS, such serial bonds and/or bond anticipation notes approved hereinbelow shall only be issued upon the receipt by the Town of confirmation that such federal and/or New York State grants have been approved;

NOW, THEREFORE, THE TOWN BOARD OF THE TOWN OF MANLIUS, ONONDAGA COUNTY, NEW YORK HEREBY RESOLVES (by the affirmative vote of not less than two-thirds of all the members of such body), AS FOLLOWS:

SECTION 1. The Town is hereby authorized to issue up to \$13,693,000 principal amount of serial bonds (including, without limitation, statutory installment bonds) pursuant to the provisions of the Local Finance Law of the State of New York, constituting Chapter 33-a of the Consolidated Laws of the State of New York (the “Law”) to finance the Project, as hereinabove described., with such amount to be reduced *pro tanto* by the amount of federal or New York State grants received by the Town in connection with the Project.

SECTION 2. It is hereby determined that the maximum estimated cost of the aforementioned specific object or purpose is \$13,693,000, said amount is hereby appropriated therefor and the plan for the financing thereof shall consist of (i) the issuance of up to \$13,693,000 in serial bonds of the Town authorized to be issued pursuant to Section 1 of this

resolution, or bond anticipation notes issued in anticipation of such serial bonds, and (ii) the assessment, levy and collection of assessments upon the benefited properties within the Skyridge Water District; (iii) certain federal and New York State grants ; and (iv) to the extent necessary, the levy and collection of taxes on all taxable real property of the Town to pay the principal of such bonds or notes and the interest thereon as the same become due and payable.

SECTION 3. It is hereby determined that the period of probable usefulness for the aforementioned specific object or purpose is forty (40) years, pursuant to subdivision 1 of paragraph a. of Section 11.00 of the Law.

SECTION 4. The final maturity of the bonds herein authorized to be issued pursuant to Section 1 of this resolution shall be in excess of five (5) years measured from the date of issuance of the first serial bond or bond anticipation note issued.

SECTION 5. The temporary use of available funds of the Town, not immediately required for the purpose or purposes for which the same were borrowed, raised or otherwise created, is hereby authorized pursuant to Section 165.10 of the Law, for the capital purposes described in this resolution. The Town shall reimburse such expenditures with the proceeds of the bonds or bond anticipation notes authorized by Section 1 of this resolution. This resolution shall constitute a declaration of “official intent” to reimburse the expenditures authorized by Section 1 hereof with the proceeds of the bonds and bond anticipation notes authorized herein, as required by United States Treasury Regulations Section 1.150-2.

SECTION 6. Each of the serial bonds authorized by this resolution and any bond anticipation notes issued in anticipation of said bonds shall contain the recital of validity prescribed by Section 52.00 of the Law and said serial bonds and any bond anticipation notes issued in anticipation of said bonds shall be general obligations of the Town, payable as to both principal and interest by a general tax upon all the real property within the Town without legal or constitutional limitation as to rate or amount. The faith and credit of the Town are hereby irrevocably pledged to the punctual payment of the principal and interest on said serial bonds and bond anticipation notes and provisions shall be made annually in the budget of the Town by appropriation for (a) the amortization and redemption of the bonds and bond anticipation notes to mature in such year and (b) the payment of interest to be due and payable in such year.

SECTION 7. Subject to the provisions of this resolution and of the Law, pursuant to the provisions of Section 30.00 relative to the authorization of the issuance of bond anticipation notes or the renewals of said obligations and of Section 21.00, Section 50.00, Section 54.90, Sections 56.00 through 60.00 and Sections 62.10 and 63.00 of the Law, the powers and duties of the Town Board relative to authorizing serial bonds and bond anticipation notes and prescribing terms, form and contents as to the sale and issuance of bonds herein authorized, including without limitation the determination of whether to issue bonds having substantially level or declining debt service and all matters relating thereto, and of any bond anticipation notes issued in anticipation of said bonds, and the renewals of said bond anticipation notes, are hereby delegated to the Supervisor of the Town, the chief fiscal officer of the Town (the “Supervisor”). Further, in connection with bonds and bond anticipation notes issued under the authority of Section 1 hereof, the power to contract with and sell bonds and bond anticipation notes to the

New York State Environmental Facilities Corporation pursuant to Section 169.00 of the Law and to approve the terms, form and content of such bonds and bond anticipation notes, consistent with the provisions of the Law, is hereby delegated to the Town Supervisor. Further, pursuant to subdivision b. of Section 11.00 of the Law, in the event that bonds to be issued for the object or purpose authorized by this resolution are combined for sale, pursuant to subdivision c. of Section 57.00 of the Law, with bonds to be issued for one or more objects or purposes authorized by other resolutions of this Town Board, then the power of the Town Board to determine the “weighted average period of probable usefulness” (within the meaning of subdivision a. of Section 11.00 of the Law) for such combined objects or purposes is hereby delegated to the Supervisor, as the chief fiscal officer of the Town.

SECTION 8. The Town Supervisor is hereby further authorized, at his sole discretion, to execute a project financing and loan agreement, and any other agreements with the New York State Department of Environmental Conservation and/or the New York State Environmental Facilities Corporation, including amendments thereto, and including any instruments (or amendments thereto) in the effectuation thereof, in order to effect the financing or refinancing of the specific object or purpose described in Section 1 hereof, or a portion thereof, by a serial bond, and, or a bond anticipation note issue in the event of the sale of same to the New York State Environmental Facilities Corporation.

SECTION 9. The Supervisor of the Town is hereby further authorized to take such actions and execute such documents as may be necessary to ensure the continued status of the interest on the bonds authorized by this resolution and any notes issued in anticipation thereof, as excludable from gross income for federal income tax purposes pursuant to Section 103 of the Internal Revenue Code of 1986, as amended (the “Code”) and to designate the bonds authorized by this resolution and any notes issued in anticipating thereof, if applicable, as “qualified tax-exempt obligations” in accordance with Section 265(b)(3)(B)(i) of the Code.

SECTION 10. The Supervisor is further authorized to enter into continuing disclosure undertakings with or for the benefit of the initial purchaser of the bonds or notes in compliance with the provisions of Rule 15c2-12, promulgated by the Securities and Exchange Commission pursuant to the Securities Exchange Act of 1934.

SECTION 11. The intent of this resolution is to give the Supervisor sufficient authority to execute those applications, agreements and instruments, or to do any similar acts necessary to effect the issuance of the aforesaid serial bonds or bond anticipation notes without resorting to further action of this Town Board.

SECTION 12. The validity of the bonds authorized by this resolution and of any bond anticipation notes issued in anticipation of said bonds may be contested only if:

- (a) such obligations are authorized for an object or purpose for which the Town is not authorized to expend money; or
- (b) the provisions of law which should be complied with at the date of the publication of such resolution are not substantially complied with,

and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of such publication; or

(c) such obligations are authorized in violation of the provisions of the Constitution.

SECTION 13. This resolution shall take effect immediately and the Town Clerk is hereby authorized and directed to cause a copy of this resolution, or a summary thereof, to be published in full, together with a notice attached in substantially the form as prescribed in Section 81.00 of the Law, in the official newspaper(s) of the Town for such purpose.

WHEREAS, a Preliminary Engineering Report and Map and Plan (“PER-M&P”) for the Project, dated June 2023, has been prepared by Barton & Loguidice, D.P.C. which describes the Project in further detail and also explains that the proposed Project would provide public water service to the proposed Skyridge Water District Extension No. 1 that would include one (1)

property owned by Clear Path at Skyridge LLC within the Town of Manlius, Onondaga County, as outlined in the Map, Plan and Report (“MPR”) for the Project, dated July 2023, also prepared by Barton & Loguidice, D.P.C.; and

WHEREAS, the Project has been classified as a “Type I Action” as defined by the State Environmental Quality Review Act (SEQRA) in 6 NYCRR Part 617.4; and

MEMORANDUM OF UNDERSTANDING

SKYRIDGE WATER DISTRICT IMPROVEMENTS PROJECT

**TOWN OF MANLIUS, TOWN OF SULLIVAN, ONONDAGA COUNTY WATER AUTHORITY
AND CLEAR PATH FOR VETERANS**

By this Memorandum of Understanding (MOU), the Town of Manlius (Manlius), the Town of Sullivan (Sullivan), the Onondaga County Water Authority (OCWA), and Clear Path for Veterans (Clear Path) document the understanding of each municipality and project stakeholder of the proposed public water infrastructure improvements, anticipated roles/responsibilities, estimated capital project costs and cost sharing for the proposed Skyridge Water District Improvements Project (the “Project”). The Project involves construction of a new transmission main, distribution mains and appurtenances in the Town of Manlius, Onondaga County, and the Town of Sullivan, Madison County for conveyance of OCWA water to the existing Skyridge Water District in the Town of Manlius, and to the proposed Skyridge Water District Extension No. 1 in the Town of Manlius and proposed Clear Path Water District in the Town of Sullivan (together “Water Districts”).

The Project seeks to provide a high quality, long-term sustainable supply of public water to the Skyridge Water District to replace that district’s aging and deficient wells, storage tank, and distribution mains, and to provide fire protection. Additionally, the Project seeks to provide public water to the Clear Path for Veterans campus located on two properties within the Water Districts, to replace Clear Path’s current well supply with a high-quality, sustainable water supply to meet current and planned facility and service expansions within the Clear Path campus on Slat Springs Road.

The proposed Project, as outlined in the Preliminary Engineering Report and Map & Plan for the Skyridge Water District Improvements, dated March 2021; Revision 1 June 2023, prepared by Barton & Loguidice, D.P.C. (B&L), would serve the existing and proposed water districts shown on Figure 6 – Skyridge/Salt Springs Joint Water Project Proposed Infrastructure, attached hereto as Exhibit A, and be comprised of the following infrastructure improvements:

- Thirty-one thousand (31,000) linear feet of 8-inch DIP water transmission and distribution main;
- Ten (10) hydrants spaced along the transmission main and within the Skyridge Water District;
- Thirty-one (31) mainline valves spaced no more than 1,000 feet apart;
- Twenty nine (29), 3/4-inch copper water service laterals extended to the right-of-way boundary and reconnection to the existing services (Skyridge Water District only);
- One (1) water service feed to the Clear Path Sullivan parcel fronting Salt Springs Road, comprised of an 8-inch ductile iron service and isolation gate valve;
- One hundred seventy-eight thousand (178,000) gallon glass-lined-steel water storage tank and access road;
- One (1) booster pump station with emergency on-site generator;
- Three (3) mainline pressure reducing valve (PRV) vaults for maintaining pressures generally below 80 psi;

- Connections to the OWCA water system near the intersection of Salt Springs Road and North Eagle Village Road in the Town of Manlius, Onondaga County, and to the 8-inch distribution main serving the Town of Sullivan's Sleepy Hollow Water District in Madison County; and,
- Decommissioning, demolition and/or removal of the existing wells, tank and distribution mains serving the Skyridge Water District.

The total estimated probable project cost for the proposed "Joint" water Project is \$13.7 million, inflated to 2025 dollars. Proposed Project infrastructure is shown of Figure 6, attached hereto as Exhibit A.

The Project will benefit the existing Skyridge Water District in the Town of Manlius, as well as the proposed Skyridge Water District Extension No. 1 in Manlius, and Clear Path Water District in Sullivan, and will therefore be planned and implemented as a "Joint" water project. Core long-term loan financing for the Project will be pursued by the Town of Manlius Town Board on behalf of the Skyridge Water District, whom shall also serve as Lead Agency for completing Project environmental review under SEQRA/SERP. The Project is currently listed on the Annual List within the New York State Environmental Facilities Corporation (NYSEFC) Intended Use Plan (IUP) for its Drinking Water State Revolving Fund (DWSRF) program.

Together, the Town of Manlius, Town of Sullivan, OCWA, and Clear Path for Veterans, as Project stakeholders, commit to working together to apply (where applicable) for supplemental grant funding through available Federal, State and local grant programs. These programs include, but may not be limited to, the Water Infrastructure Improvement Act (WIIA), Congressional Spending Requests, funding through NYS Senators and Assembly representatives, Empire State Development, and others for which the Project and stakeholders are eligible applicant(s).

The Town of Manlius and Town of Sullivan agree that the capital project cost for Project infrastructure planning, design, and construction will be paid for by benefitting customers within Town Water Districts formed in accordance with Article 12-A and improved in accordance with Article 12, Section 202-b of NYS Town Law and as approved, where required, by the NYS Comptroller's Office. Further, the long-term plan of finance and annual user costs will be calculated and assessed to benefit the Water Districts' customers in proportion to the benefit derived, as may be determined by the Town and Manlius Town Board, Town of Sullivan Town Board, and OCWA during development of an Intermunicipal Agreement (IMA).

OCWA intends to sell water to the Water Districts' customers based on its annual Rate Schedule No. 2A – Gallons, General Residential Service – Quarterly, and Rate Schedule No. 8A, Commercial/Light Industrial Service – Quarterly, published each year by OCWA with an effective date of January 1. This rate schedule has been used to estimate the annual water purchase cost for a typical single-family user within the Skyridge Water District PER-M&P, and within the Map, Plan & Reports prepared for the proposed Skyridge Water District Extension No. 1 and Clear Path Water District, respectively.

The Town of Manlius, Town of Sullivan, OCWA, and Clear Path for Veterans agree to work together in good faith and with due diligence to establish the terms and conditions for planning any implementing an OCWA water supply to the Skyridge Water District and Clear Path for Veterans campus, and for developing and Intermunicipal Agreement for said supply.

**RE: Skyridge Water District Extension No. 1
Review of Map, Plan & Report**

Dear Supervisor Deer:

At the request of the town, we have performed a review of the proposed Skyridge Water District Extension No. 1 Map, Plan & Report, dated July 2023 and prepared by Barton & Loguidice. With regard to the report and specific concerns expressed by board members, we offer the following:

It is our understanding that the primary need for this project is to provide public water service for the Clear Path for Veterans site located in the Town of Sullivan. Secondary to this, it is our understanding that the existing 29 residents within the existing Skyridge Water District (located along Horseshoe Lane and Salt Springs Road) have expressed concerns regarding their existing water system and water quality, and have requested to benefit from this project. The current proposal provides public water (via OCWA) to both the Clear Path for Veterans site (partly in the Town of Manlius and partly in the Town of Sullivan) as well as the existing Skyridge Water District.

From a technical perspective, we are generally in agreement with the findings and proposed plan. While other alternatives are available, each presents challenges and drawbacks. The primary benefit however of the current proposal is that it provides the most reliable long-term solution to providing public water. This is in large part due to system redundancy with connections to two locations within OCWA's service network, creating a loop and the ability to serve the subject area from two different locations in the event of a future main break or needed maintenance.

Other alternatives:

Connecting to existing mains along Route 5 – the primary concern with this alternative, outside of any specific hydraulic data, would be a significant increase in elevation differential. Route 5 is currently at an elevation of between 500' and 550'. The elevation at the Clear Path site is approximately 800', and at the Horseshoe Lane properties approximately 1,000'. The Sleepy Hollow pump station is at an elevation of between 650' and 700' (approximately). This alternative would still require a booster pump(s) and new storage tank, but would also result in a "dead end" in the system that could potentially result in added long-term operation and maintenance costs.



Extension from the existing Sleepy Hollow pump station only – Extension of this main to either the Clear Path site alone, or up to the existing Skyridge Water District site would certainly be shorter, but would still require a booster pump(s) and new storage tank, but would also result in a “dead end” in the system that could potentially result in added long-term operation and maintenance costs.

Creating a looped connection between these two alternatives would certainly address some concerns, but would bring the configuration closer to that of the currently proposed alternative. In addition, the elevation differential at the Salt Springs Road and Eagle Village Rd is far less substantial. The elevation at Eagle Village Rd is approximately 815', far more gradual and less substantial than that at Route 5.

Need for a new water tower:

A new water tower would likely be necessary regardless of option. The existing water tank at Horseshoe Lane is likely not to current public water system standards, and likely undersized to provide adequate volumes for future anticipated use. Relocating the tower is not entirely necessary, however it is proposed to be at a higher elevation and will provide better service and potentially be able to serve a larger future area.

Land Acquisition:

There is a line item for land acquisition in the proposed cost estimate. A value of \$20,000 has been included. Whether or not this is adequate is unknown, but if property is acquired from an overall larger piece of property, it can be limited to typically a 100' x 100' parcel with either owned access strip or an access easement to the site.

Equivalent Dwelling Units:

The subject of equivalent dwelling units (EDU's) is likely the most controversial with respect to this project. This is typically the most practical method to distribute project cost burden throughout the district. Often, vacant land is assigned a value during formation of the district simply because it's impractical to assign an alternative value purely on speculation that public water will encourage development on a specific property. The exception here is that Clear Path is anticipating development in the near future which will likely change the actual EDU's. It is currently unclear how the increase in EDU's on the Clear Path properties over the 30-year bonding period will be accommodated. It is our opinion however that while the residents of the existing Skyridge Water District will clearly benefit from the implementation of this project, they are bearing a significantly large portion of the unfunded cost burden.

Future Development and additions to the district:

These types of projects, especially those with long extensions to existing connection points, will likely increase development pressures along the water main route. The lack of gravity sewers is a slightly limiting factor, but it should be anticipated that development pressures will increase, and there will be requests to connect to the existing main once installed. How many connections and how quickly they surface is entirely speculative however and often impractical to plan for.



Other concerns:

It should be noted that the provided Map, Plan & Report, as is common, does not include any detailed design calculations or data. There have been no hydraulic models prepared (that have been provided), data on subsurface geology along the proposed (or alternative) routes, surveys, property appraisals, etc. While this is not uncommon at this stage, several factors could impact final design. It is entirely likely that project costs would change once final detailed designs are prepared. It does however appear that indicated construction cost estimates are conservative. One item not specifically addressed is encountering shallow bedrock along the proposed route. This could significantly increase project costs if encountered and not considered.

WHEREAS, an Order Calling a Public Hearing was duly adopted by this Town Board on June 28, 2023, reciting the filing of said map, plan and report, the improvements proposed, the boundaries of the proposed extended district, the fact that the map, plan and report described in said Order also contained the method of financing any improvements, and that said map, plan and report were on file in the Town Clerk’s Office for public inspection, and stating all other matters required by law to be stated and the date of the hearing for the extension being July 12, 2023 at 6:35 pm at the Town Hall, 301 Brooklea Drive, Fayetteville, New York, as the place where the Town Board would meet for a Public Hearing to consider said map, plan and report, and to hear all persons interested in the subject thereof, concerning the same, and to take such action thereon as is required or authorized by law; and

WHEREAS, such Order was duly published on July 2, 2023 in the Syracuse Newspaper, the official newspaper for the Town, further, said Order was duly posted on July 5, 2023 on the official sign board which is kept for the posting of official notices; both Publication and Posting was in full compliance with [Town Law § 209-d](#); and

WHEREAS, such Order further provided that the Town Board was to consider at said hearing the environmental significance of the extension of said Water District and construction of related improvements and specifically whether the extension of said Water District and construction of related improvements would result in any adverse environmental impacts; and

WHEREAS, a Public Hearing on the Extension was duly held by the Town Board on July 12, 2023, in the Town Hall, 301 Brooklea Drive, Fayetteville, New York, and said public hearing was continued, re-noticed and held on July 26, 2023 at which all interested persons desiring to be heard were heard, including those in favor of, and those opposed to, the extension of the Water District and construction of related improvements; and

WHEREAS, in connection with the Extension, a Long Environmental Assessment Form (“EAF”) was filed with the Town Board and in the office of the Town Clerk from which the Town Board duly considered and reviewed all potentially significant environmental impacts as required by Environmental Conservation Law Article 8 (State Environmental Quality Review Act—SEQRA and 6 NYCRR Part 617); and

NOW, THEREFORE, BE IT RESOLVED THAT upon the evidence adduced at said Public Hearing, and all evidence in the record before the Town Board it is hereby determined as follows:

FINDINGS OF FACT

1. The boundaries of the proposed extension of said Water District are set forth in Schedule A, which is attached hereto and made a part hereof.
2. That said area shall be incorporated into and shall become part of the Water District.
3. That the improvements which have been constructed to serve the Extension consist of water mains, distribution pipes, hydrants, related water works and facilities for the purposes of supplying residents or occupants of the Extension with pure and wholesome water. The remaining facilities serving the Extension are currently in existence as part of the distribution system for the Water District, and will require no additional construction or cost.
4. The cost of the improvements necessary to extend service from the existing facilities of the Water District to the properties within the Extension will be financed entirely by the landowner of the lands to be included in the Extension and no public funds will be expended for that purpose.
5. The annual cost for debt service on capital improvements per typical equivalent unit throughout the Water District and which will also be charged to benefited parcels within the Extension is the sum of \$2,172.00 and the estimated net annual cost for usage and commodity charges, operation and maintenance of the improvements which will be levied upon each occupied equivalent unit is the sum of \$424.0000 and, therefore, the annual average cost per typical occupied property in the Water District for the aforesaid usage, commodity, operation and maintenance and debt service on capital improvements is the combined sum of \$2,596.
6. The estimated cost for connection, or hookup to the supply facilities for the one parcel extension, including any costs associated with the tie-in to the adjacent property in the Town of Sullivan, shall not exceed the sum of \$116,000.00.
7. That the cost of the extension and construction of related improvements of the Water District shall be charged on a benefit basis to those properties located within the service area to be benefitted and served by the extension as part of the Water District.
8. A Long Environmental Assessment Form (“EAF” – attached), was filed by the Town of Manlius as the Sponsor of the Extension. The EAF identified no adverse environmental impacts which would be caused by the Extension.
9. Prior to the adoption of this Order, the Town Board adopted findings that the Extension of the Water District will give rise to no adverse environmental impacts.

Based upon the foregoing, it is

HEREBY RESOLVED AND DETERMINED:

- a) That the Order Calling Public Hearing was published and posted as required by [Town Law § 209-d](#), and is otherwise sufficient;
- b) That all property and property owners within the proposed extended district are benefitted thereby;
- c) That all property and property owners benefitted thereby are included within the limits of the proposed extended district;
- d) That it is in the public interest to extend said district; and be it further

RESOLVED AND DETERMINED that the Extension, now known as “Skyridge Water District Extension No. 1”, as set forth more fully in the map, plan and report be approved; that the improvements therein mentioned, as constructed, be accepted for public dedication upon the approval of the New York State Department of Health and the Onondaga County Department of Health, and the Extension shall be bounded and described as set forth in Schedule A attached hereto and made a part hereof; and it is further

RESOLVED AND DETERMINED that this Order is subject to a Permissive Referendum as provided in [Town Law § 209-e](#). Petitions for the requesting of said Permissive Referendum are available at the office of the Town Clerk. Said Petitions must be completed and filed in the office of the Town Clerk, 301 Brooklea Drive, Fayetteville, New York within thirty (30) days of the filing of this Order with the Town Clerk.

2. The Pledge of Allegiance

Supervisor Deer called the meeting to order at 6:30 PM. Councilor Italiano led the Pledge of Allegiance. Supervisor Deer welcomed everyone and thanked all for attending.

3. 6:33 PM Open Podium

Bill Grey, Manlius, thanked the town staff for assisting him while he was investigating a zone change application.

4. Public Hearing CANCELLED – Zone Change Application – Turnwood Development – Garden Park Apartments – Highbridge Street (tax Map No. 093.-01-05.1) Commercial A (CA) to Residential (R5)

The applicant has withdrawn the application. Supervisor Deer stated that the application is considering a Planned Unit Development District (PUD)

5. 6:38 PM Comprehensive Plan – Public Hearing

The public hearing was reopened at 6:38 PM.

Debra Tooker, Manlius, stated that she is concerned about the proposed quarry and that the current requirements for the zone change are not comprehensive enough. Ms. Tooker discussed studies that she thought should be completed prior to the approval of a Quarry.

Barb Wilson, Manlius, stated that she believes that a zone change for the quarry would be for short term monetary gain and would destroy the environment around the quarry.

Craig Dudczak, Manlius, read aloud a letter on behalf of Pat Beech. Ms. Beech discussed her concerns regarding the increased risks for adverse health effects of a quarry.

Karen Ayoub, Manlius, requested the Town Board proceed slowly with the large number of important agenda items. Ms. Ayoub stated that there is a large amount of information being considered and that is a lot for residents to digest. Ms. Ayoub discussed the referenced re-zoning in the comprehensive plan and how a blanket change in zoning could have negative effects. Conversation ensued regarding the proposed re-zoning project. Discussion ensued regarding the comprehensive plan, what it accomplishes and how it affects zoning. The Town Board explained that the comprehensive plan does not make any zone changes or re-zoning.

Mark Matt, Fayetteville, stated he is speaking not as a trustee but as a resident and he thanked the Town Board for compiling the Comprehensive Plan. Mr. Matt expressed concern regarding the additional stresses that high density housing puts on infrastructure. The town will need to work with agencies to develop away from villages. Mr. Matt expressed concern regarding the pressure that solar farms and residential development are putting on agriculture. Mr. Matt stated that quarry projects should be allowed to move through the normal planning process. Mr. Matt encouraged the town to cultivate additional partners and discussed the limited public participation.

John Belton, Manlius, stated that he is opposed to the zone change that would permit the new quarry. Mr. Belton discussed his concerns regarding what would happen if the quarry was

approved and then abandoned and asked the town board to be cautious of tying the town to a quarry that could be abandoned.

Casey Cleary-Hammerstedt, Fayetteville, thank all that participated in the development of the Comprehensive Plan. Ms. Cleary discussed what happens when a quarry is approved, how it affects the community and discussed her fears of climate change. Ms. Cleary asked the Town Board to vote on the project as it has been worked on thoroughly for a long time and has been available to the public for review.

Tim Kelly, Fayetteville, asked how much money has been spent to date on the Comprehensive Plan. Councilor Bollinger stated they do not have the final invoice at this time and that the Town will be receiving a large amount of grant funding.

Bob Wheeler, Manlius, discussed his experience in other communities and what makes a community a good places to live. Mr. Wheeler stated that he supports the plan, and he will hold the Town Board accountable for the protection of the environment that was laid out in the plan.

Craig Dudczak, Fayetteville, discussed the history of the quarry, the previous legal battles regarding spot zoning and how not having a comprehensive plan has affected that process. Mr. Dudczak stated that he finds it disingenuous that the Town Board is stating that this is not a zone change but the plan does identify areas where zone changes would be supported and more easily occur.

Town Clerk Weber stated she received a letter from Mark Olson that he is in support of the Kinsella Quarry.

Councilor Denton made a motion, seconded by Councilor Waters, to close the public hearing at 7:15 PM in the matter of the Town of Manlius Comprehensive Plan.

Mark Stanbro, Chittenango, stated that each resident in the Skyridge Water District is unanimous that they would like the Town Board to pursue funding to construct new water mains and related improvements.

Stephen Benson, Manlius, stated he has yet to see any characterization of the development that is going to go in Skyridge (on the ClearPath properties) and who will benefit from it. Mr. Benson asked what is planned for that area after the large water main is approved. The plans indicate that whatever is planned for up there needs a lot of water. Mr. Benson stated that there is no transparency.

Mary Karpinski, Manlius, stated the residents of the district have submitted a list of questions concerning the Skyridge Water District Improvement Project. Ms. Karpinski stated the residents of Salt Springs Rd. are concerned about the six miles of their road that will be under construction to install the water line to Skyridge. Ms. Karpinski discussed what Barton and Loguidice will earn if the project goes through. Ms. Karpinski asked that the town board come visit the site.

Melissa Spicer, Manlius, introduced herself as a resident and the founder of ClearPath. Ms. Spicer stated the investment in the ClearPath property was for the betterment of the community. Ms. Spicer wanted to promise the community that as the landowner that there is no ill intent, only one single effort to make ClearPath a good model for others to emulate.

Jim Gerace, Manlius, asked if the board is asking the Salt Springs homeowners to pay for any of the Skyridge project. Supervisor Deer explained the project and stated no.

Karen Ayoub, Manlius, asked if there a vailed exit plan if the grant funding does not come through as expected. Supervisor Deer stated that if the town does not get the WIIA grant, the plans will change and further discussed other options.

Town Clerk Weber read aloud a comment from online attendee Anne. Who pays for project overage? Do those costs go to the Manlius taxpayer? Does this bonding affect Manlius' credit score? Town Supervisor Deer discussed the budgeting process and stated that this bond will have little to no impact on the town's credit score.

Joe Messineo, Manlius, stated that there are wetlands in the area where the construction will take place. Mr. Messineo further commented that there will be excess material created from excavating. Mr. Messineo stated that the grade near the tank needs to be evaluated and landscape features will be impacted. Mr. Messineo asked that the town board visit the site and the blasting could possibly affect the wells in the area. Mr. Messineo asked what would happen if the residents in the district do not pay and he further disputed the idea that a bond of this size would not impact the town's bond rating.

Town Clerk Weber read aloud a letter from Joann Marciano, Manlius. The letter laid out several objections and questions to the Skyridge Water District project.

Matt Napierala, Napierala Consulting, read aloud a statement from David Muraco, Manlius. The letter asked why the residents of Salt Springs were not notified of the Skyridge Water District public hearings. Mr. Muraco asked several questions about the project and the considerations be taken into account when proceeding. Mr. Muraco stated that he has a pivotal piece of property to this project, and no one has contacted him. Mr. Muraco asked to see the budgeted line items behind this project.

Chris Flaherty, President & CEO of ClearPath for Veterans, read aloud a statement of support for the proposed water district and improvements. Mr. Flaherty discussed the mission of ClearPath and how ClearPath serves veterans. Mr. Flaherty asked the town board to approve the project and stated that the benefits of the project outweigh the risks.

Phil Berrigan, Manlius, stated that from his perspective, the town is responsible no matter what to do something to fix the water issue. Supervisor John Deer discussed the role the water district would play in repairing the water issue.

Councilor Waters made a motion, seconded by Councilor Italiano, to continue the public hearing in the matter of Skyridge Water District Improvement pursuant to Section 202b of Town Law to July 26th and to publish notice of said continuation in the Syracuse Newspapers at least 10 days before said continuation.

Councilor Waters made a motion, seconded by Councilor Denton, to waive the reading of the public notice in the matter of proposed local law 2023-9 Amending Chapter 127 Of the Town of Manlius Code (Subdivision) To Clarify That Each Individual Subdivided Lot Shall Directly Tie into Public Water Available to Such Lot as outlined in the resolution prepared by the Attorney for the Town.
